

GREAT EASTERN AREA RALLY (GEAR) October 23-27,2024

Dear Exhibitor/Vendor/Seminar Presenter:

The Eastern Area of FMCA is excited to announce GEAR 2024 will be held at the West North Carolina Agricultural Center in Fletcher, NC. The rally officially opens Wednesday October 23, and ends Sunday morning, October 27. Our members look forward to checking out vendors/exhibitors and purchasing RV related and other items. We invite commercial vendors to join us at GEAR. Vendor set up is on Tuesday, October 22 and Wednesday, October 23. Business hours for vendors will be 9:00 a.m. to 4:00 p.m. Thursday and Friday; 9am to 2pm on Saturday. These hours will allow you time to attend evening entertainment. Our estimated attendance is 300 RVs.

The Davis Building will be the venue for Commercial Vendors. The building is completely climatically controlled. The cost is \$200 per display space. The indoor vendor spaces are 10' x 10', one table, and two chairs. The sharing of vendor spaces is permissible. The cost is \$100 per shared vendor space. There will be a \$25 charge for an electric drop if ordered by October 1, 2024, and \$40 if ordered after that date. The outdoor vendor spaces are 40' x 20'. The cost is \$200 per display space. There is <u>no</u> electricity available outside.

Each vendor must carry their own risk insurance on their property and must be covered by a comprehensive general liability insurance policy in the amount of at least \$1,000,000 combined single limit for bodily injury and property damage per each occurrence, **naming Family Motor Coach Association and the fairgrounds as an additional insured**. This certificate must be received before you can exhibit.


We also invite you to **advertise in our rally program**, which members receive upon their arrival. The size of a full-page black and white ad is 7" wide x 10" tall at a cost of \$125 per page. The size of the one-half page ad is 7" wide x 5" tall and cost \$75. A quarter page ad at 3 1/2" wide and 2 ¹/₂" tall and cost \$45. The cost for a color ad on the back cover is \$400. Color ads on the inside, front and back covers are \$350. Full-page color ads within the body of the program are \$250. We are also offering a two-page color centerfold spread for \$600. All ads must be submitted in print ready to arrive no later than September13, 2024, to the FMCA national office in Cincinnati.
